### 2. Site Browsing and General Information Collection

1. You can browse the Site anonymously. You are not required to reveal any Personal Information to access general content. However, access to certain services—such as donation processing, class registration, or communication—may require you to provide Personal Information.
2. While browsing, our servers may automatically collect certain general information ("General Information"), including:
  - Date and time of your visit
  - Referring website or URL (if you linked to us from another site)
  - Browser type and version
  - Your device and operating system
  - Visitor "hit" count (page views, click patterns, etc.)
3. This General Information **does not identify you personally**. Mission Gyan does not link General Information with your Personal Information.
4. General Information is used for statistical analysis, site performance, and user engagement tracking. Mission Gyan may share this non-personal data with partners, advisors, or analytics providers at its discretion.

### 3. Use of Personal Information

Your Personal Information will be used for internal purposes only, including but not limited to:

- Sending communications such as updates, newsletters, annual reports, donation receipts, and thank-you emails
  - Processing donations and issuing relevant receipts or certificates
  - Maintaining a secure and confidential internal database of donors, volunteers, and students
  - Responding to queries, requests, and support tickets

1. Access to your Personal Information is restricted to only those individuals or organizations authorized by Mission Gyan.

  4. Mission Gyan **retains ownership** of all such information and does not authorize any third party to use your data for their own purposes.
  5. Mission Gyan shall not be held responsible for misuse or unauthorized disclosure of your Personal Information by any third party who is not under our control or employment.
